- 8 questions, each worth 10 marks each. Total of 80 marks
- "Objective Test Examination" format a style of complex multiple-choice examination.
- 2 and a half hours duration
- Delegates may use their official MSP manual: "Managing Successful Programmes" only

Candidates require a minimum of 40 marks (50%) to pass Please note that candidates must pass the Foundation exam before attempting the Practitioner exam. By successfully passing the Practitioner exam, delegates attain 'Registered Practitioner' status.
