This course comprises sessions dealing with version control systems, how Git works, installation, managing a local repository, branching, merging, resolving conflicts, pushing to and pulling from a remote repository, rebasing, getting set up on GitLab, forking, pull requests, and managing repositories on GitLab.

Exercises and examples are used throughout the course to give practical hands-on experience with the techniques covered.
