■ **Professional experience:** Two years, including one year of work experience in ICT risk management

■ **Risk management experience:** Project activities totaling 200 hours

■ **Other requirements:** Signing the PECB Code of Ethics

**PECB Certified DORA Lead Manager**

■ **Exam:** PECB Certified DORA Lead Manager exam or equivalent

■ **Professional experience:** Five years, including two years of work experience in ICT risk management

■ **Risk management experience:** Project activities totaling 300 hours

■ **Other requirements:** Signing the PECB Code of Ethics

**PECB Certified DORA Senior Lead Manager**

■ **Exam:** PECB Certified DORA Lead Manager exam or equivalent

■ **Professional experience:** Ten years, including seven years of work experience in ICT risk management

■ **Risk management experience:** Project activities totaling 1,000 hours

■ **Other requirements:** Signing the PECB Code of Ethics

The ICT risk management activities should follow best practices and include the following:

■ Drafting a DORA implementation business case

■ Managing a DORA implementation project

■ Implementing an ICT risk management framework

■ Managing documented information

■ Implementing corrective actions

■ Monitoring and improving the performance of the ICT risk management framework
