- **Other requirements:** Signing the PECB Code of Ethics

PECB Certified ISO 22301 Lead Implementer

- **Exam:** PECB Certified ISO 22301 Lead Implementer Exam or equivalent
- **Professional experience:** Five years, including two years of work experience in Business Continuity Management
- **BCMS project experience:** Project activities totaling 300 hours
- **Other requirements:** Signing the PECB Code of Ethics

PECB Certified ISO 22301 Senior Lead Implementer

- **Exam:** PECB Certified ISO 22301 Lead Implementer Exam or equivalent
- **Professional experience:** Ten years, including seven years of work experience in Business Continuity Management
- **BCMS project experience:** Project activities totaling 1,000 hours
- **Other requirements:** Signing the PECB Code of Ethics

***Note:** PECB Certified Individuals who do possess the Lead Implementer and Lead Auditor Credentials are qualified for the respective **PECB Master Credential**, given they have taken 4 additional Foundation Exams which are related to this scheme.*

To be considered valid, these implementation activities should follow the best implementation practices and include activities such as:

- Initiating a BCMS implementation
- Implementing a BCMS
- Monitoring and managing a BCMS implementation
- Continually improving a BCMS
