 - **Domain 4:** Implementation of a QMS based on ISO 9001
 - **Domain 5:** Monitoring and measurement of a QMS based on ISO 9001
 - **Domain 6:** Continual improvement of a QMS based on ISO 9001
 - **Domain 7:** Preparation for a QMS certification audit
- Upon the successful completion of the exam, you can apply for one of the credentials shown in the table below. You will receive a certificate once you fulfill all the requirements related to the selected credential.

PECB Certified ISO 9001 Implementer

- Exam: PECB Certified ISO 9001 Lead Implementer Exam or equivalent
- Professional experience: Two years, including one year of work experience in Quality Management
- QMS project experience: Project activities totaling 200 hours
- Other requirements: Signing the PECB Code of Ethics

PECB Certified ISO 9001 Lead Implementer

- Exam: PECB Certified ISO 9001 Lead Implementer Exam or equivalent
- Professional experience: Five years, including two years of work experience in Quality Management
- QMS project experience: Project activities totaling 300 hours
- Other requirements: Signing the PECB Code of Ethics

PECB Certified ISO 9001 Senior Lead Implementer

- Exam: PECB Certified ISO 9001 Lead Implementer Exam or equivalent
- Professional experience: Ten years, including seven years of work experience in Quality Management
- QMS project experience: Project activities totaling 1,000 hours
- Other requirements: Signing the PECB Code of Ethics

Note: *PECB certified individuals who possess both the Lead Implementer and Lead Auditor credentials are qualified for the respective **PECB Master Credential**, given they have taken 4 additional Foundation Exams related to this scheme.*

To be considered valid, the audit activities should follow best audit practices and include the following:

- Drafting a QMS implementation plan
- Managing or leading a QMS implementation
- Initiating a QMS implementation project
- Implementing a QMS
- Conducting process mapping activities
- Managing documented information
- Establishing performance indicators and evaluating the QMS performance
- Performing continual improvement activities

Content:

Day 1: Introduction to ISO 9001 and the initiation of a QMS implementation

Day 2: Implementation plan of a QMS

Day 3: Implementation of a QMS

Day 4: QMS monitoring, continual improvement, and preparation for the certification audit

Additional Information:

Educational approach

This training course is learner-centered and contains:

- Theories, approaches, and best practices used in management system implementation, operation, maintenance, and continual improvement
- Theoretical basis supported by practical examples, throughout the four days of the training course
- Interaction between the trainers and participants by means of questions and discussions
