This is an entry-level credential.

There are no prerequisites on professional or management system project experience required. Thus, following the training course, passing the exam and applying for the certificate are the only certificate program requisites that certificate holders shall meet before obtaining the certificate.

- **Designation:** PECB Certificate Holder in ISO/IEC 27001:2022 Foundation
- **Training course:** Completion of the PECB ISO/IEC 27001:2022 Foundation training course
- **Exam:** Pass the PECB ISO/IEC 27001:2022 Foundation exam
- **Professional experience:** None required
- **MS audit/assessment experience:** None required
- **ISMS project experience:** None required
- **Other requirements:** Signing the PECB Code of Ethics
