- QMS project experience: Project activities totaling 200 hours
- Other requirements: Signing the PECB Code of Ethics

PECB Certified ISO 9001 Lead Auditor

- Exam: PECB Certified ISO 9001 Lead Auditor Exam or equivalent
- Professional experience: Five years, including two years of work experience in Quality Management
- QMS project experience: Project activities totaling 300 hours
- Other requirements: Signing the PECB Code of Ethics

PECB Certified ISO 9001 Senior Lead Auditor

- Exam: PECB Certified ISO 9001 Lead Auditor Exam or equivalent
- Professional experience: Ten years, including seven years of work experience in Quality Management
- QMS project experience: Project activities totaling 1,000 hours
- Other requirements: Signing the PECB Code of Ethics

Note: *PECB certified individuals who possess both the Lead Implementer and Lead Auditor credentials are qualified for the respective **PECB Master Credential**, given they have taken 4 additional Foundation Exams related to this scheme. To be considered valid, the audit activities should follow best audit practices and include the following:

- Planning an audit
- Managing an audit program
- Drafting audit reports
- Drafting nonconformity reports
- Drafting audit work documents
- Reviewing documented information
- Conducting on-site audit
- Following up on nonconformities
- Leading an audit team
